- 2) The SB740 Compliance Reporting, the pupil teacher ratio is within compliance at 19.35.1 as we know the standard is 25:1. However, the 40/80 is currently out of compliance. Chris mentioned that Charter Impact will help assist our school for the UPK reporting. The 990 is officially due on November 15th.
