Chris went over the highlights and stated we'll have to spend a little more in certain areas where we had a decrease in enrollments. The revenue projected to decrease by 1.365 M in the FY21/22 compared to FY 21/22 Approved budget. He also noted the SCALE does not anticipate projected cash shortages for FY 21/22, FY 22/23, or FY23/24.

Chris gave an update regarding the graduation rate. As of 3/2/22 the expected 4-year cohort graduation rate for 2022 is 82%, which is about a 25% increase from 2021 (57.1%) and about a 30% increase from 2020 (52.9%). This rate can increase pending tracking unaccounted students and updating the students exit codes in CalPads. He also stated that is our charter graduation rate is poor, it brings down our district's graduation rate.

Chris also updated the board members that our employee staff are scheduled to return to working full time hours as of April. He also mentioned the next board meeting being in person and will continue to meet on Saturdays.
