James went though highlights and preliminary COLA increase at 8.13%. May revise (from the Governor) to come out next week, though James does not anticipate much change.

The budget assumes an enrollment of 1060, or 1007 ADA. New space rent included in this budget's 1st year payment of 230k settlement from 17-18 initiated in FY 22-223. This budget includes Year 2 of this payback. The year-end surplus forecasted at 4% of the total expense. The end of the year cash balance is projected at 4.354m.

B. April Financials

James went over the highlights ACCS recommended SCALE for 100% full funding for the next 4 years. Along with CDE's recommendation, this should be done in the next 2 weeks. 2023 - 2024 budget process underway – based on ADA of 997.50 (1050), but work continues. May revise from governor due on May 15th. This surplus is now forecasted at 356l higher education consulting fees.
