Mr. Surmaiean provided the highlights. Mr. Surmaiean stated revenue has decreased by \$440.8k vs budget, and expenses have decreased by \$381.0k vs budget. Surplus is now forecasted at \$746k. ADA projections are at 960 students vs budget at 1045. The 40/80 has fallen out of compliance – mostly due to large increases in revenue. The End of the Year balance is projected at \$4.045m.

### **B.** Certification of Completion for SPED

Ms. Carter went over the policy behind the Certificate of Completion, and presented all the ways students could graduate. Ms. Carter also presented the three (3) requirements needed to earn a diploma.
